The HI Committee was organised into two Subcommittees, the Best Practice Subcommittee and the Statistical Analysis Subcommittee:

- The objective of the Best Practice SC is to develop guidance notes on health insurance pricing and reserving to present to members in 2009. The interim goal in 2008 is to create a resource centre on the SAS website of health insurance related material which will be useful for actuaries practicing in the field.
- The Statistical Analysis SC will analyse Ministry of Health data posted on its website and identify medical cost trends which will allow HI actuaries to separate general medical cost inflation from policyholder behaviour induced inflation. The SASC will develop a template to capture MoH data.

The HI Committee issued its annual Healthcare and Financing Report 2006/07 in November 2007. The report covered developments affecting health insurance in Singapore for the period Jan 2006 to Jun 2007. The work to prepare the Report was led by **Moi Seng Yew** with the editorial support of **Chen Wei Hin.**

Teng Yuen Ning was appointed as the liaison with the Institute of Actuaries of Australia Health Practice Committee.

Council Members of the Society met with Mr Low and other MAS officers to provide MAS with an update of the Society's activities over the past year or thereabouts, and to seek input for any future developments that they suggest.

The conversation covered topics such as:

- the implementation of the new process to allow Council to admit Fellows from 'non-recognised associations';
- the change in the UK Profession's rules that now permits local Fellows to nominate SAS as their primary professional regulator;
- the clarification of the Society's Mission and Vision statement;
- the implementation of the mandatory CPD requirements for SAS Fellows;
- · Conferences and similar events run by the Society;
- The proposed Appointed Actuaries Symposium;
- Appointed Actuaries Induction Course; and
- the desire to prepare SAS Guidance Notes which is constrained by our available resources.

2. Society Representatives at other events

The President represented the Society at a number of events during the year:

- Spoke at IAAust Christmas dinner: December 2007

Additionally, the President has been appointed to the Board of Examiners of the Singapore College of Insurance.

3. International Actuarial Association

The key issue currently being considered within the IAA is probably education where the IAA is progressing a plan to implement an international-based level education for use by all IAA members. Plan would be for it not to replace the UK or US exams but be used by those members with less developed educational programs which may not be in line with new IAA educational requirements.

Another, related, issue concerns what the role of the IAA should be - there being some parallels here with the situation of SAS. The main questions seems to be whether IAA should set global minimum standards or just be an international lobbying and networking group for actuaries.

2. Exposure Drafts and Extraordinary General Meetings

EGMs were held as follows:

9 March 2007 - An Exposure Draft was circulated to members on 21 February 2007 concerning Guidance Note L02 – Valuation of Policy Liabilities for Life Insurance Business. The Life Insurance Committee had previously discussed a preliminary draft with Appointed Actuaries. At the EGM, three proposed changes to the Exposure Draft were discussed and approved and the Guidance Note so amended was then approved by voting members.

3. Constitutional Changes

No changes were made to the Society's Constitution during the 2007/08 session.

4. Appointed Actuary Induction Course

During the year five newly-appointed Appointed Actuaries undertook the Society's Induction Course. The Council is grateful to **Khoo Kah Siang**, **Eric Seah and Richard Holloway**, who conducted these courses on the Society's behalf and to **Lee Wai Yi** and Khoo Kah Siang for updating the course notes.

5. Appointed Actuaries Symposium

The Life Committee organised the first SAS Appointed Actuary Symposium on 4 October 2007. The Symposium attracted about 45 participants (including speakers) and covered topics ranging from AA roles, regulator's view on stress testing and also the future development in IFRS4. Arising from the discussions it was clear that there is a demand for further guidance notes or professional standards to be prepared by the Society on matters such as stress testing, par fund management and conflicts of interest.

6. Modelling Module CA2 Workshop

On behalf of the Society, **Mark Birch** organised a Faculty and Institute of Actuaries Modelling Module CA2 Workshop on 28/29 August 2007 in Singapore.

The Workshop was led by Mark Birch and supported by **Irma Hadikusuma**. It was attended by 24 candidates and 14 of those were successful in passing CA2. This pass rate is commensurate with that achieved on the corresponding courses held in the UK since the eligibility requirements had been relaxed.

Mark Birch is arranging a further CA2 workshop in Singapore on 22/23 April 2008, to be led by Professor John Shepherd of Macquarie University, Sydney.

7. Commercial Actuarial Practice

Good progress had been made by **Andrew Linfoot** and **Mark Birch** with the aim of holding the Institute of Actuaries of Australia's Commercial Actuarial Practice course in Singapore in September 2007. However, the event was cancelled by the Institute when it discovered that there were insufficient numbers of students wishing to take the course outside of Australia at that time.

8. Joint Professionalism Course

The Professional Affairs Committee is developing a joint professionalism course, which is intended to be endorsed by all the main examining bodies. This would enable actuaries within the region to satisfy the professionalism course requirements of their examining body by attending a course locally. The inaugural course is tentatively planned for the week commencing 4 August 2008.

9. National Longevity Insurance Committee (NLIC)

Following a meeting with the NLIC, attended by **Andrew Linfoot** and **Khoo Kah Siang**, a small working group comprising **Au Sing Hong**, **Khoo Kah Siang**, **Andrew Linfoot**, **Frank McInerney** and **Ken Ng** prepared a submission to the NLIC regarding the proposed longevity insurance scheme. Following further input by Council Members the proposed submission was circulated to members on 17 December 2007 and submitted to the NLIC on 27 December 2007.

The submission was received positively by the NLIC and the Society was the only professional organisation specifically named by the NLIC, in its final report to the Minister for Manpower, as having provided input.
