Alex Kimura



Alex Kimura was appointed as Chief Strategy Officer of Aviva Asia in September 2014 and Managing Director of Friends Provident International Japan in September 2015. His current responsibilities include Strategy, Corporate Development and Mergers and Acquisitions, Digital and Analytics and Transformation for Asia. Alex brings with him a wealth of operating expertise and experience in the financial services industry and the Asian markets. A main area of focus has been on digital innovation where he spearheaded efforts to launch the Digital Garage and also form the JV with Hillhouse and Tencent. He is also the current Chairman of the MAS Digital Innovation Roundtable.
